### Southeastern Louisiana University

The Linus A. Sims Memorial Library will host the traveling exhibition "Lincoln: The Constitution and the Civil War" from February 9, 2011 to March 25, 2011. Lieutenant Governor Jay Dardenne opened the exhibition on Tuesday, February 15. The Library is one of only 25 libraries in the United States selected to host the traveling exhibition, which was organized by the National Constitution Center, Philadelphia, and the American Library Association (ALA) Public Programs Office, Chicago. Librarians Lynette Ralph, Kathryn Munson and Mary Frances Marx wrote the grant that made the exhibition possible.

The Government Documents Department will be loaning five National Park Service handbooks to the U.S. Government Printing Office for the remainder of the year. The handbooks will be included in an exhibit GPO is doing to commemorate its 150th anniversary.

Mary Lou Strong, Jean Caswell, and Ladonna Guillot are teaching their second session of Senior CHAT (Consumer Health Awareness Training) to senior citizens served by the Tangipahoa Voluntary Council on Aging. Senior CHAT is funded by a grant from the National Network/Libraries of Medicine South Central Region. Its purpose is to improve health outcomes among the senior citizens by promoting health literacy through instruction in the use of NIHSeniorHealth and MedlinePlus databases.

2009 from McGill University in Montreal. He previously worked at the University of New Orleans' Louisiana and Special Collections department and with Library Associates Companies (LAC Group).

#### Digitization of the Charity Hospital Reports (1842-1966)

"The Charity Hospital Reports" are being digitized by the Rudolph Matas Library of the Health Sciences of Tulane University under a NLM grant awarded August 2010-June 2011 for a project entitled: "Early Medical Journalism of Louisiana, A pilot project for the preservation and sharing of Nineteenth Century Medical Publications of Louisiana [National Library of Medicine (NLM) Prime Contract No.

N01-LM-6-3505; HHSN276200663505C]." The grant supports the digitization of the Report of the Board of Administrators of the Charity Hospital, to the General Assembly of Louisiana (also known as Charity Hospital Reports ) beginning with those publications published in 1842. These reports were published in Louisiana as state government reports and seem to be unique to the Matas Library collection. The reports contain morbidity and mortality information for New Orleans, including the yellow fever epidemics, venereal disease statistics along with physician information.

The successful digitization of this set of reports will allow the Matas Library to continue the preservation and the sharing of the fragile publications that make the core of its historic medical collection. The documents will also be available in the LOUISiana Digital Library. The Matas Team hopes to continue the digitization to



widely share the content of the fragile 19th to early 20th century bound local journals and reports, books of importance to medicine in Louisiana, and topical subjects such as yellow fever and other past epidemics. The origin of the Rudolph Matas Library dates from the founding of the Medical College of Louisiana (now Tulane University School of Medicine) in 1834, with the first mention of the Library in the faculty minutes of the College in 1844. The historic medical collection contains a wealth of early American medical journalism, treatises and pamphlets, many published in Louisiana from the period before the Civil War. These works are not generally available electronically. Users must still use the Library's card catalog to discover resources at the Matas Library for publications from the nineteenth century and early twentieth century.

**Sandy Himel**, Head of Research and Government Information, and Lance Chance, Instructional Services Librarian, presented, "Working in Rhythm: Building the Foundation of the Cajun and Creole Music Collection at the University of Louisiana at Lafayette" at the Association for Recorded Sound Collection's annual conference, which was held in New Orleans.

#### Grants

Three grants funded by the UL Lafayette Student Technology Enhancement Program (STEP) in 2010 support library services. Susan Richard, Associate Dean of Libraries, was awarded \$36,891 to implement "Reference Online Center Upgrade." This grant includes new computers in the Reference Online Center and a webcam for Skype service at the reference desk. Sheryl Curry and Lance Chance received \$5,902 for "Edith Garland Dupré Library SMART Classroom Upgrade and Enhancement" to improve equipment used for Instructional Services. Louisiana Room Librarian Jean Kiesel will purchase a digital reader/printer for the Special Collections Department with a \$9,436 award for "Digital Technology Application for Library Special Collections Materials on Microfilm and Microfiche."

#### Accreditation

The University of Louisiana at Lafayette recently learned that the University's accreditation has been reaffirmed by the Southern Association of Colleges and Schools (SACS). As part of its reaffirmation of accreditation, the University was required to develop and implement a Quality Enhancement Plan (QEP). For the QEP, the University chose to address the first-year experience in an effort to increase retention, success, and engagement of the first-year student and, hopefully, to make a continued impact beyond the first year. The QEP includes a first-year seminar, library learning commons, Ernest J. Gaines Center at Dupré Library. and learning communities. Through UNIV 100: First-year Seminar - Cajun Connection, the University strives to meet six student learning outcomes. One of the learning outcomes is "Select, locate and

evaluate information resources held in Dupré Library and in digital formats." Many of the librarians participated in the course content for the class, and they created a library assignment for the course. The QEP was well-received by SACS.

# University of New Orleans

Florence M. Jumonville, chair of the Louisiana and Special Collections Department, contributed two articles to Louisiana Libraries in 2010. "Sallie Farrell: Second First Lady of Louisiana Libraries" (Spring) profiled Louisiana's second state librarian (1962-1975), who died on November 13, 2009, just six weeks shy of her one hundredth birthday. "When First We Met: Conferences, Officers, and Activities of LSLA and LLA, 1909-1932" (Fall) chronicled the early years of LLA and a little-remembered predecessor organization, the Louisiana State Library Association. In addition, Florence presented a paper, "The Soul of Mars': New Orleans Sheet Music During the Civil War," at Words and Music, A Literary Feast in New Orleans, 2010. The Pirate's Alley Faulkner Society hosted the November event. Florence's biographical sketch of Essae M. Culver, Louisiana's first state librarian, was among the first group of 300 entries published in KnowLA: Encyclopedia of Louisiana, published online by the Louisiana Endowment for the Humanities.

The Louisiana and Special Collections Department made its television debut on January 12 when WWL-TV's Frank Davis introduced viewers to the K & B Archives. Capitalizing on New Orleanians' propensity for nostalgia, Davis presents semi-weekly news segments entitled "Naturally N'Awlins," focused on obscure but appealing aspects of local culture. The locally headquartered K & B Drug Stores, which was founded in 1905 and was sold to Rite Aid in 1997, evokes fond memories of its purple packaging and store-brand products that ranged from liquor to ice cream, from iodine to pencils, from aspirin to adhesive tape. It was a "natural" for "Naturally N'Awlins!"
